

Advocate SPOTLIGHT: Katherine Levine

To get readers better acquainted with the Members of the Advocate Society, we spotlight a Member in each issues. This winter's issue, we feature a Question and Answer with Katherine Levine, who is in private practice and Chair of the Advocates Society Amicus Poloniae Clinic Support Committee.

Why are you a member of the Advocates Society?

The Advocates Society gives me the opportunity to volunteer at the Amicus Poloniae Clinic, access to professional and personal networking and mentor young lawyers and law students.

The Amicus Poloniae Clinic is a way for me to connect with and help the local Polish community. Oftentimes people who come to the legal clinic, do not speak English, and do not know the legal system and do not have the resources to hire an attorney. Volunteering makes me "feel good" and provides a sense of satisfaction. As lawyers, we tend to overthink and stress out over our cases. Volunteering takes me away from work and provides some "personal" time.

Having the opportunity to meet fellow attorneys (i.e., like-minded colleagues who understand our daily challenges we face as lawyers) it is comforting, uplifting and often leads to friendships. Moreover, membership at the Advocates Society provides me with a platform for



mutual source of exchanging ideas and resources. I enjoy attending the Advocate Society's Special Events (Judges' Nights, Installation Dinners, Polish Constitution Day parade, etc.) Again, for me this is an opportunity to socialize, get out and meet fellow attorneys and "me time" away from work. Lastly, the Advocates Society enables me to help, mentor or be a resource for young lawyers and law students.

Give us an example of how being a member of the Advocates Society empowered you as an attorney.

Judge's Corner: The Honorable Diane Pezanoski

To get readers better acquainted with the judges who support the Advocates Society, we have launched a special section in the newsletter to honor those amazing judges. Here is what Judge Pezanoski shared with us.

Judge Pezanoski, for those who are not known to you, please introduce yourself.

I was sworn in as an Associate Judge on January 6, 2020. I spent the first 22 months as a judge in the Traffic Division, working under the excellent leadership of our esteemed Advocates' member, Acting Presiding Judge Diann Marsalek. As of November 1, 2021, I have been assigned to the Child Protection Division, where I am excited to continue my judicial career.

Prior to becoming a judge, I spent 31 years in various positions with the City of Chicago Law Department. For the last nineteen years at the City, I was the Deputy Corporation Counsel of the Aviation, Environmental, Regulatory and Contracts Division. I started my legal career at Freeborn & Peters, where I worked for three years as a litigation associate. I graduated from Northwestern University Pritzker School of Law in 1985.



What do you love about your job?

What I enjoy most about being a judge is the public service aspect. Judges must place ego aside and be the face of justice to those who appear before them. It is especially rewarding to handle cases involving self-represented litigants (SRLs). I work hard to try to be competent at explaining the law and legal procedures to SRLs, and putting people at ease in the courtroom.

I also love the law, especially researching and learning new areas and new issues. Being a judge, no matter where one is assigned, provides endless learning opportunities.

What do you miss about being a lawyer?

I miss working with my former colleagues at the City of Chicago Law Department, who are outstanding lawyers and wonderful people. Otherwise, as a judge, I continue to do what I loved doing best as a lawyer – researching the law, analyzing the issues, and engaging in legal writing. It has been a seamless transition for me.

Did you have mentors as an attorney or a judge? What is the most valuable lesson(s) you learned from your mentor(s)?

Yes, I had so many role models and mentors as an attorney, starting with my early years in private practice, and especially in my decades at the City of Chicago Law Department. Some of my best mentors at the City left there to join the bench, so they gave me great advice on how to achieve that goal. They also underscored the importance of hard work and preparation. The best attorneys leave no stones unturned, knowing the facts and the law of their cases in depth.

Do you have any advice for attorneys trying to become a judge?

First and foremost, work hard at being the best lawyer you can be, and always conduct yourself with civility in your dealings with judges, colleagues, and adversaries. You will develop a reputation for competence and integrity that will form a solid base from which you can then pursue a judicial career.

Second, join bar associations and become actively involved in at least one of them, including participation on a Judicial Evaluation Committee, which will give you an inside view of the process. Third, make sure to get at least some trial experience, which can be in State and/or Federal courts, and/or administrative tribunals, and keep records of your legal experience (trials, appeals, significant motions, etc.) and adversaries.

Start early and, above all else, be persistent. The road to the bench can be long and winding, so work on eliminating any weaknesses, and enhancing your strengths, and keep at it.

Do you have any advice for lawyers to improve in court?

Do your homework – know the law, read the relevant statutes and cases, and make the best arguments on your client's behalf, clearly and concisely, and well-supported by the law. That is your job. Always remember to address the judge, not your adversaries, when appearing in court. And posture – standing tall, with your shoulders back and head held high – goes a long way to conveying a sense of confidence in your arguments.

I am very proud of my Polish heritage. I grew up as one of nine children, the oldest of eight girls, in a working-class Polish Catholic family in Racine, Wisconsin. I was the first in my family to go to college, and I am so appreciative of the Polish National Alliance Scholarship I received that helped me pay for tuition. I was very close to my Polish grandparents, on my Father's side, learning to make, among other things, pierogi and kielbasa with my Grandma. My favorite part of my Polish upbringing was dancing with a folklore dance group throughout high school, and with the Syrena Polish Dancers while in college at the University of Wisconsin in Milwaukee. My grandparents and great-grandparents came to this country in the early 1900s, leaving everything behind, and starting life here working in the coal mines of Pennsylvania, and eventually working their way to the Midwest Polish communities in Milwaukee and Racine.

My involvement with the Advocates and Polonia has helped me keep a strong connection to my Polish heritage, and become acquainted with the Polish community in Chicago. Through the Advocates, I was able to volunteer at the Amicus Poloniae Legal Clinic, a longstanding and excellent clinic that provides free legal services to mostly Polish-speaking clientele. Volunteering there has been one of the most rewarding experiences in my entire legal career. I urge any lawyers to participate at the once-a-month clinic, along with any Polish speakers who can help translate.

Fun Polish Facts

If you ever visit the palace of Versailles in Paris, you will find a painting of Maria Leszczyńska (a.k.a. Marie Leczinska). She was a Polish princess and Queen consort of France from 1725 until 1768 by marriage to Louis XV. Queen Marie was daughter of King Stanislaus I of Poland and Catherine Opalińska, and her 42-year service was the longest of any queen in French history.

Although Queen Marie was not initially respected by the royal court, as she was not French-born, she won the country's heart and maintained the role and reputation of a simple, dignified Catholic queen. She functioned as an example of Catholic piety and was famed for her generosity to the poor and needy through her philanthropy, which made her very popular among the public her entire life as queen.
